**Incident: Fatal Motor Vehicle Collision**

On Wednesday, December 6, 2007 the Egg Harbor Township Police Department responded to a fatal motor vehicle collision which occurred at approximately 07:16 in the intersection of Delilah Rd and Doughty Rd in the Farmington section of the township.

A 2001 Ford Focus operated by a Margaret Lattanzi-Baird wt/f 57 yoa of Wildwood Crest NJ was turning left from Doughty Rd onto Delilah Rd when the vehicle was struck in the intersection by an east bound motorist.

A 1999 Dodge Ram pickup operated by Marcus T Debow wt/m 20 yoa of Hammonton NJ was proceeding east on Delilah Rd when the operator failed to stop as he approached and entered the intersection in observance of a red traffic signal.

A collision occurred in the intersection when the front of the Dodge Ram pickup collided with the driver's side doors of the Ford Focus.

Margaret Lattanzi-Baird sustained fatal injury and was pronounced dead at scene.  
Ms. Lattanzi-Baird was unrestrained in the vehicle.

EHF EMS and Farmington Volunteer Fire Dept. responded.

Traffic was detoured for approximately 2 hrs while the collision was being investigated and cleared. Issuance of a motor vehicle summons is pending the completion of the collision investigation. The collision is being investigated by the Egg Harbor Twp. Police Dept. Traffic Safety Unit in cooperation with the Atlantic County Prosecutor's Office Fatal Collision Unit.
